### REQUIREMENTS

- Children Should be between the ages of birth to 17 years old
- Total household income should not exceed \$2100 per month
- Must live in the Phelan, Pinon Hills, Wrightwood area
- Must be willing to provide documents to verify children's age such as a birth certificate
- Must be willing to provide documents to verify total household income such as check stubs, food stamps, state/county assistance, spousal support or unemployment
- All children must be present on the day of the event to receive gifts.

- We reserve the right to refuse any family as recipients in the Angel Tree Gift Giving Program.
- We reserve the right to refuse any family that does not qualify or provides untrue or misleading information in their application.
- Acceptance into the Angel Tree Gift Drive program does not guarantee children will receive gifts listed.
- If accepted, families may not participate in any other toy/gift give-away program such as Toys For Tots, etc.
- Families participating in other toy/gift give-away programs will be dropped from the Angel Tree Gift Drive and will not be notified.

- Please limit gift items to under \$65.00 per child. **We will not be able to include bikes as a gift this year.**
- All Children must be present on the day of the event, otherwise, the gifts will not be given out - NO EXCEPTIONS.
